We have made a strong start to 2024 with some great results in investigations already, showing our continued dedication to keeping the people of Cheshire safe.

Our response teams have really driven our golden hour principles and our response times have been really impressive at 91% for Grade 1s and 92% for Grade 2s.

Our action taken rate is at 24% for this quarter, with a domestic abuse action taken rate of 21% - a fantastic collective effort. Rape and serious sexual offences outcomes remains strong and Detective Superintendent Banusic and I are exceptionally proud of all of the work our PIP2 teams have delivered across all areas of vulnerability and serious

Our beat teams have continued to drive our proactivity in relation to CBOs, closure orders and some complex serious acquisitive crime investigations.

Domestic Abuse, DA Champions, Domestic Violence <u>Disclosure Scheme</u> (Clare's Law)

Tackling Domestic Abuse (DA) in all its forms remains a priority for Cheshire Police. This focus has seen the action taken rate for DA offences increase from 11.4% to 20.5% in the last three years. This performance is a strong indication of improved service to victims and focus on the pursuit of perpetrators to prevent future offending. Our focus on DA is broader than traditional criminal justice outcomes. There are now more than 50 DA Champions across the Constabulary, with DA Champions ideally placed within operational and investigative roles to advise and support colleagues to deliver the best service for victims. All DA Champions received ABE Video Interview training to better support victims of DA from January 2024. To further develop the DA Champions network and influence, quarterly forums are scheduled throughout 2024 to bring the team together, share best practice and identify areas for development.

Focus on prevention of future harm is also prioritised in relation to DA. The Domestic Violence Disclosure Scheme (DVDS), Clare's Law has also seen enhancements in 2024. In 2023 the Constabulary considered, processed and disclosed Right to Ask (RTA) and Right to Know (RTK) disclosures within the 28 statutory disclosure timescales in 93.87% and 89.25% of cases respectively. By introducing daily focus and governance in relation to DVDS via Area Bronze Commanders and Pacesetter meeting victims and future victims are receiving a further enhanced service with RTA and RTA disclosures completed within 28 days in 98.1% and 97% of cases respectively. In addition, there are currently no outstanding DVDS disclosures outside of the 28 day statutory period. This means, a victim who is in a potentially dangerous relationship and at risk from a DA perpetrator will be informed of those risks in a prompt and effective manner, enabling better informed




